



Safeguarding Statement:

At St. Luke's we believe that everyone has the right to be loved and accepted. Staff and Governors are concerned that all aspects of school life are "fair" and "safe" for children, staff, parents/carers and the wider community. To gain an accurate voice from the pupils we have a Justice Committee and respect and safety are always discussed as being 2-way relationships irrespective of age.

We have a range of policies in place and available on our website and in school that are designed to achieve a fair, safe and harmonious environment. Policies provide guidance on the acceptable standards of behaviour expected of all staff, governors, children and adult visitors to our school.

St. Luke's Primary School adheres the definition of safeguarding used in the <u>Children Act 2004</u> and in the Department for Education and Skills (now DfE) guidance documents <u>Working together to safeguard children</u> and <u>Keeping Children Safe in Education</u>, to promote children's and our school communities' welfare.

This can be summarised as:

- Protecting children from maltreatment
- Preventing impairment of children's health or development
- Ensuring that children growing up with safe and effective care
- Undertaking that role to ensure children have optimum life chances

Our governing body supports the school by complying with the <u>Education Act 2002 (section 175)</u> and we keep up to date with guidance issued by the Secretary of State and LA. We have a nominated governor who works with our safeguarding team to stay regularly informed of information and to critically challenge school leadership.

We follow Education Department and local authority guidance on safeguarding children and safer recruitment to ensure we provide a safe environment and take action to identify and protect any children or members of our learning community who may be at risk of significant harm. We especially scope training around the document Keeping Children Safe in Education with it's yearly updates.

We are an Operation Encompass school. Which involves working closely with the Police when they have been involved with a family. Please click on the link below for further information.

Through self-review and monitoring we promote safe practice and ensure that adults working with children receive the necessary training for their roles. We work in partnership with other agencies providing services for children and their families to promote their well-being.

Working together:

We can only be successful in keeping children safe if staff and parents work together to ensure that children are able to voice their concerns. It is important that adults speak to their children about how they can keep safe, teach them how to behave appropriately, set rules and deal with challenging behaviour.
