Develop a growth mindset, resilience and good mental health and well-being.

#### 1. Aims

This policy aims to ensure that:

- Suitable education is arranged for pupils on roll who cannot attend school due to health needs
- Pupils, staff and parents understand what the school is responsible for when this education is being provided by the local authority

# 2. Legislation and guidance

This policy reflects the requirements of the Education Act 1996.

It is also based on guidance provided by the London Borough of Newham.

### 3. Responsibilities of the school

#### 3.1 If the school makes arrangements

Initially, the school will attempt to make arrangements to deliver suitable education for children with health needs who cannot attend school.

- The Deputy Headteacher (DHT) will be responsible for making and monitoring these arrangements.
- The DH will immediately consult with parents and pupils about these arrangements as soon as it has been determined that they will need to be schooled offsite for a while.
- The school will loan appropriate remote device (laptop or ipad)
- If pupil is to be educated from a hospital the class teacher will work with the DHT to make sure appropriate work is sent to the hospital teacher

• The school will work with the family to reintegrate the pupil back into school at the soonest safe time and this may require a staggered return.

## 3.2 If the local authority makes arrangements

If the school can't make suitable arrangements, the London Borough of Newham will become responsible for arranging suitable education for these pupils.

In cases where the local authority makes arrangements, the school will:

- Work constructively with the local authority, providers, relevant agencies and parents to ensure the best outcomes for the pupil
- Share information with the local authority and relevant health services as required
- Help make sure that the provision offered to the pupil is as effective as possible and that the child can be reintegrated back into school successfully

When reintegration is anticipated, work with the local authority to:

- Plan for consistent provision during and after the period of education outside the school, allowing the pupil to access the same curriculum and materials that they would have used in school as far as possible
- Enable the pupil to stay in touch with school life (e.g. Via school social media Schoolping & Instagram & through newsletters, emails, invitations to school events or internet links to lessons from their school)
- Create individually tailored reintegration plans for each child returning to school
- Consider whether any reasonable adjustments need to be made

#### 4. Monitoring arrangements

This policy will be reviewed annually by the Governing Board.
